COMMENTS IN WP (C) NO. 1935/2023

FILED BY JOGEN BORUAH – VS- THE STATE OF ASSAM & 5 OTHERS

That the petitioner Mr. Jogen Boruah was serving as Library Bearer at Murkong Selek College, Jonai w.e.f. 19-09-1985, the appointment of Mr Jogen Boruah at the said post was approved by the Director of Higher Education, Assam vide DHE Letter No. G(A)ACN.9/93/41 dated 26/02/1993 and Confirmation of his service vide DHE Letter No. G(A)AC/N/9/93/pt/20 dated 02/01/1997.

As per DHE order Mr. Jogen Boruah, Library Bearer was serving in the Scale of Pay of Rs. 930-15-1005-20-1145-EB-20-1225-30-1435/- P.M. plus other allowances as admissible under the Rules.

That sir, Mr. Jogen Boruah retired from his post on 30/06/2022 and his pension proposal was submitted at the office of the Accountant General (A&E), Assam, Maidamgaon, Beltola, Guwahati-29 on 13/06/2022. After the submission of the pension proposal by Mr. Jogen Boruah, it has come to the notice of the Office of the Accountant General (A&E) Assam that Mr. Jogen Boruah's Scale of Pay was wrongly fixed as on 01-01-1996 is to be 2450 to 3670/- instead of 2530 to 4390/- which is to be revised from the scale of 900 – 1435 instead of 930 – 1735 as per ROP 89.

In this matter, a letter was issued by the office of the Accountant General (A&E), Assam to the Principal, Murkong Selek College, Jonai to re-examine and resubmit the pension proposal of Mr. Jogen Boruah after necessary correction of scale of pay w.e.f. the date of joining to the date of retirement in the service book. After making all the necessary rectification the pension proposal of Mr. Jogen Boruah was resubmitted to the office of the Accountant General (A&E), Assam.

After resubmission of the pension proposal of Mr. Jogen Boruah, Retd. Library Bearer, Murkong Selek College, Jonai the office of the Accountant General (A&E), Assam has found that he has overdrawn a sum of Rs. 4,55,100/- (Rupees Four Lakhs Fifty-Five Thousand One Hundred) only.
